DECISION ON THE SELECTION OF THE BEST BIDDER

Article 1.

The Recommendation of the Public Procurement Commission No: 1-11-16-4-3553-15/16 of 06.12.2017. was adopted and the **Contract for the Public Procurement of Training Services for Trainers from Aviation English**, is awarded to the bidder **Mayflower College, 1 Radford Road, Playmounth PL 1 3 BY, UK**, as the best rated bidder for the offered price: **8.136,00 BAM**.

Article 2.

This Decision will be published on the web site www.bhansa.gov.ba simultaneously with reference to the bidders, who participated in the public procurement procedure, pursuant to Article 70. paragraph (6) of the Public Procurement Law.

Article 3.

This Decision shall enter into force on the date of its adoption and shall be delivered to the bidders who have participated in the public procurement procedure, in accordance with Article 71. (2) of the Public Procurement Law.

Explanation

By Decision on the Initiation of the Procedure for the Procurement of Training Services for Trainers from the Aviation English Language, Decision No: 1-11-16-4-3553-3 / 17 of 30.10.2017, the Commission prepared an Invitation for Submission of Bids, in accordance with Article 7. paragraph (3) of the Ordinance on the Procedure for Awarding Services Contracts in Annex II, Part B of the Public Procurement Law. The Invitation for Submission of Bids is in accordance with Article 7. paragraph (3) of the Ordinance on the Procedure for Awarding Services Contracts in Annex II, Part B of the Public Procurement Law, published on the website of the Bosnia and Herzegovina Air Navigation Services Agency and sent on the same day to the bidders at three addresses:

1. Anglo-Continental, 29-35 Wimborne Roda, Bournemouth, BH 2 6 NA, England
2. MLS International College, Hinton Road, Bournemouth BH1 2 EN, England

3. Mayflower College, 1 Radford Road, Plymouth PL 1 3 BY, UK

Deadline for submission of bids was 12.04.2017 at 12:00h

At a session, held on 05.12.2017 at 9.00h, the Commission noted that within the foreseen deadline, the bids of three suppliers were received, as follows:

1. MLS International College, Hinton Road, Bournemouth BH1 2 EN, England
2. Anglo-Continental, 29-35 Wimborne Roda, Bournemouth, BH 2 6 NA, England
3. Mayflower College, 1 Radford Road, Plymouth PL 1 3 BY, UK

The established value of the bids in the subject of procurement of training services for trainers from the aviation English language is, as follows:

1. **Mayflower College, 1 Radford Road, Plymouth PL 1 3 BY, Uk** sa cijenom ponude: **8.136,00 KM**
2. **MLS International College, Hinton Road, Bournemouth BH1 2 EN, England** sa cijenom ponude: **12.485,21KM**
3. **Anglo-Continental, 29-35 Wimborne Roda, Bournemouth, BH 2 6 NA, England** sa cijenom ponude: **13.934,38 KM**

For these reasons, pursuant to Article 64. paragraph (1) item b) of the Public Procurement Law, i.e. the criterion of the lowest price of technically satisfactory bid, it was decided as in the provision of this Decision.

LEGAL REMEDY:
